Re: compliance with the requirements of the Regulation of the European Parliament and the Council of the EU dated December 18, 2006 No. 1907/2006 regarding the Registration, Evaluation and Authorization of Chemicals (REACH)

### DECLARATION

#### Dear customers!

PRIVATE JOINT-STOCK COMPANY "KAMET-STEEL" (hereinafter referred to as PJSC "KAMET-STEEL") undertook to strictly comply with the requirements of the Regulation of the European Parliament and the Council of the EU dated December 18, 2006 No. 1907/2006 (REACH) regarding registration, evaluation, authorizations and restrictions on the use of chemicals.

After a thorough assessment of the REACH Regulation, our company certifies that the metal products produced by PJSC "KAMET-STEEL" fully comply with the established requirements of the REACH Regulation:

1. Pursuant to Article 3(3)\* of the REACH Regulation and in accordance with ECHA instructions, PJSC "KAMET-STEEL" is a manufacturer of "**products**" for our customers from the EU. Our metal products, namely continuous cast billets, hot-rolled square or round billets, hot-rolled pipe billets, wire rod in coils, long shaped profiles (reinforcing steel, channels, angles), grinding steel balls, rough axles for railway transport, etc. is considered "products". Our "products" do not involve "intentional release of substances". Accordingly, we do not see any requirement for registration for the "products" we supply to you.

2. In accordance with the requirements of Article 33 of the REACH Regulation (Obligation to transfer information about substances contained in products), we declare that in metal products produced PJSC "KAMET-STEEL":

- none of the chemicals causing very serious concern (SVHC substances) and meeting the criteria of Article 57 of the REACH Regulation, in a total amount equal to or exceeding 0.1%, is absent;

- none of the particularly dangerous substances that require a special permit and are listed in Annex XIV of the REACH Regulation are absent.

3. In respect of the requirements of Article 67 of the REACH Regulation (A substance, as such or in a preparation or article, which is subject to Annex XVII restrictions shall not be manufactured, sold or used unless it complies with the conditions of such restrictions), we declare that in metal products, produced by PJSC "KAMET-STEEL", none of the substances with restrictions specified in Annex XVII of the REACH Regulation are contained in a quantity amounting to a total concentration equal or above 0,1%.

Since certain changes are often made to the REACH Regulation (adding SVHC substances, adding particularly hazardous substances to Annex XIV, adding restricted substances to Annex XVII), PJSC "KAMET-STEEL" undertakes the responsibility to timely assess these changes and update this Declaration in order to reflect those changes.

Hereby, PJSC "KAMET-STEEL" also declares that it is not subject to the Regulation of the European Parliament and the Council (EC) No. 1272/2008 of December 16, 2008 (CLP) on the classification, labeling and packaging of substances and mixtures. As a result, PJSC "KAMET-STEEL" is not obliged to issue any safety data sheets for our metal products (or articles).
